Subject: Grant of recognition to the school from class I-X  
(without aid) w.e.f. academic session 1987-88.

Sir,

With reference to your application on the subject noted above, I am directed to grant recognition to your school from class Ist to X (without aid) w.e.f. 1987-88 session, subject to the fulfilment of the following terms and conditions :-

1. That the school shall abide by the provisions of Delhi School Education Act & Rules, 1973 framed thereunder as well as the instructions issued from time to time.
2. That the school shall admit students without any discrimination of caste and creed and preference shall be given to the students of Faiz Road, Karol Bagh and surrounding areas.
3. That the school shall appoint more full-time qualified and eligible staff for all the classes of the school as per the present norms of the department.
4. That the school shall equip the Science Lab. as per the norms of the department/CBSE and suitable facilities for practical work shall be provided to the students.
5. That a proper library shall be established and facilities for reading-room shall also be made available for students as well as teachers. Books as per the ratio of 10 books per student may be added and facilities of reading room may also be provided immediately.
6. That adequate sports materials shall be purchased and made available to the students immediately.
7. That the school shall strictly abide by the provisions of Delhi School Education Act & Rules, 1973 and payment shall be made as per section 10(1) of Delhi School Education Act, 1973 to all the employees through crossed cheques.
8. That the enrolment in each section shall not exceed the number of students calculated @ 12 sq.ft. per student for the available floor area of the class-room and the school shall provide adequate and sufficient accommodation as per the norms of the Directorate of Education, Delhi, in each class.

That Health Certificate shall be obtained from M.C.D. within a month.

10. That the scheme of management shall be got approved from the department immediately.
11. That the school shall not run any pre-primary and unrecognised classes or any other activities within the school premises and all the recognised classes shall be run at one place. Nursery classes be removed from the premises of the school, if any. No branch of this school shall be run under the banner of the recognised school.
12. That the school shall dispense with the services of unqualified and over-aged staff, if any, immediately.
13. That all the facilities prescribed under Rule 50 & 51 of the DSER, 1973 shall be made available to the students. Provisions of Rules 6, 7 and 9 be strictly observed.
14. That the service contract between the management and the employee shall be executed immediately.
15. That the arrangement of good drinking water shall be made available to all the students as well as to the teachers and sanitary facilities shall also be provided to the students adequately. Health Certificate may be obtained from the Local Body within a month.
16. That the management of the school shall create a Reserve Fund of Rs.10,000/- (Rupees ten thousand) only in a Joint Account in the name of the Director of Education and the Manager of the school in any scheduled bank within a month.
17. That the violation of any instructions/orders/conditions/rules and regulations of the department shall lead to the withdrawal of recognition of the school and class XI shall not be opened without the prior approval of the Director of Education, Delhi.
18. That the school society shall apply for the allotment of land and will construct the building as per specifications of the Directorate of Education, Delhi within a period of three years.
19. That the Management of the school shall provide all the facilities as per rule 50 and all conditions as required under Rule 51, shall be complied with.
20. That the management of the school will settle the price of the land with the DDA/Ministry of Works & Housing, whichever has allotted the land, under intimation to the Dte. of Edn.
21. That a report about the fulfilment of the above conditions giving the extent to which each condition is fulfilled, shall be sent to the Education Officer every six month.
